Sealed bid offers in the prescribed form for the sale of unserviceable vehicles will be received by the Disposal Committee thru the Secretariat, General Services Section, Administrative Division of DENR Regional Office 4<sup>th</sup> floor, Sevilla, City of San Fernando, La Union on **July 31, 2023** and the bid will be opened at **1 o'clock in the afternoon**, Conference Room 3<sup>rd</sup> floor in the presence of the Disposal Committee and COA representative as witness.

Bidders may obtain further information on the Bid Form and other bidding documents from the Chairman, Disposal Committee at the DENR-I, City of San Fernando, La Union.

Participating bidders shall state the price offered per lot and kindly ensure that the written amount of bid offer in the bid proposal form is correct or else it shall be automatically disqualified. Each bid must be accompanied by bidders' bond equivalent to ten percent (10%) of the total bid price. If the winning bidder refuses to sign the Notice of Award (NOA), the bid bond shall be automatically forfeited in favor of DENR-ROI without the need of any further legal action.

Any offer not accompanied by the required bidder's bond shall be automatically rejected and shall not be read nor enter in the record of bidding.

Participating bidders are presumed to have inspected the aforesaid unserviceable vehicles at the place where they are located.

Bid proposal in the prescribed price quotation.

All necessary expenses incurred pertinent to the sales shall be at the expense of the buyer. The unserviceable vehicles herein advertised for auction sale shall be sold on an "As is where is Basis". The removal of the above-mentioned unserviceable vehicles shall be completed within five (5) calendar days from the Notice to proceed of withdrawal and shall be the sole responsibility of the buyer.

The DENR Regional Office reserves the right to reject any and all bids, waive any informality in the proposal received and to accept such bid most advantageous to the government.
